# MANAGEMENT WORKING GROUP TERMS OF REFERENCE

#### **Purpose**

Our purpose is to ensure that the objects identified in Section 3 of our Constitution are implemented using the authority provided by the Trustees under section 14. These objects will be delivered through the St Paul's Boxing Academy CIO Development and Equity Plan.

# **Objectives**

- To develop and continuously improve St Paul's Boxing Academy CIO.
- To raise funds to help sustain St Paul's Boxing Academy CIO.
- To provide training and development opportunities for coaches, volunteers and Trustees.
- To deliver events to engage the community with the St Paul's Boxing Academy CIO.
- To deliver the Equity Action Plan.
- To promote and gain support for St Paul's Boxing Academy CIO.

# **Scope**

The Management Working Group is an advisory group to the Trustee Board with delegated financial responsibility for the day to day running of the club. All monies are held in dedicated bank account with 3 signatories, any two of whom can authorise payments.

The financial year of the Academy will end on 31st March.

An audited statement of annual accounts will be presented by the Treasurer to the Trustee Board.

#### **Membership**

As per Section 14 of the Constitution, the Management Working Group comprises of at least one trustee, the Head Coach plus any other co-opted members as deemed appropriate.

Members will meet as a group as and when required, but no less than quarterly, in order to ensure the smooth running of the Academy. They will have the power to make strategic recommendations to the Trustee Board and any day to day decisions as necessary for

the smooth running of the club.

**Convening of Management Working Group Meetings** 

a) The Management Working Group will be convened by the Secretary and held as

required and no less than four times per year.

b) The quorum required for business to be agreed at Management Working Group

meetings will be three.

Role and responsibilities

c) To advise and make recommendations to the Trustee board on all matters relating

to operation of St Paul's Boxing Academy CIO.

d) To oversee the day-to-day operation of St Paul's Boxing Academy CIO and take

decisions in the following areas:

i. Membership - all members will be subject to the rules and regulations

outlined within the Constitution of the St Paul's Boxing Academy CIO and by

joining the Academy will be deemed to accept these regulations and any

related policies, procedures and codes of practice that the Academy Trustees

adopt.

ii. Coach and volunteer recruitment, training and development in all areas

including safeguarding.

iii. All safeguarding matters relating to children and vulnerable adults.

iv. The development and monitoring of new policies, procedures and codes of

practice.

Financial management to ensure the effective running of the Academy. ٧.

Any grievance or disciplinary matters relating to infringement of Academy vi.

regulations, policies, procedures or codes of practice. Any disciplinary or

suspension action is to be ratified by the Trustee Board.

e) To promote St Paul's Boxing Academy CIO within the community by developing and

maintaining links with external partners.

f) To appoint sub-committees as necessary, and to co-opt individuals on a temporary

basis. Appointment of external advisers to the Management Working Group as

necessary to fulfill its business will be subject to the approval of the Trustee Board.

Reporting

The Management Working Group is a sub-committee of the Trustee Board with

delegated powers which are reviewed from time to time. Minutes from the Management

Working Group will be circulated to the Trustee Board.
